Name of Participant:

Under Tennessee law, an equine sponsor or equine professional, or any other person, including corporations and partnerships, are immune from liability for the death or injury of a participant, which resulted from the inherent risks of equine activities. Under Mississippi law, an equine activity sponsor, or equine professional is not liable for an injury or the death of a participant in equine activities resulting from the inherent risks of equine activities. Inherent risks of equine activities mean those dangers or conditions that are an integral part of engaging in an equine activity, including, but not limited to, the possibility of an equine behaving in ways that may result in injury, harm, or death to persons on or around them and/or the unpredictability of an equine's reaction to such things as sounds, sudden movement, unfamiliar objects, persons or other animals.

I recognize that horseback riding, assisting in riding lessons, caring for and being in the near vicinity of horses, are high risk activities that can result in mortal or serious injury and/or property loss both to my person and my property, as well as the person or property of others.

I hereby agree that my involvement in such activities and/or my presence at Southern Reins Center for Equine Therapy is at my own risk, and that I hereby assume full responsibility for, any death or bodily injury to myself or others, and damage or destruction of my property or the property of others. My responsibility includes, but is not limited to, (1) payment of medical costs for myself and others that I may have injured, (ii) costs to replace my own property or the property of others that I may have lost, destroyed, or damaged, and (iii) damages for other non-medical and non-property items such as pain and suffering and lost wages.

I acknowledge that Southern Reins Center for Equine Therapy requires me to wear a safety helmet while riding. I understand and acknowledge that the risk for head injuries and death is significantly reduced by wearing appropriate headgear. I hereby release, waive and discharge Southern Reins Center for Equine Therapy, its officers, directors, employees, volunteers and agents, as well as any affiliated entities or persons, including but not limited to the owners, operators, employees and agents of the facility where Southern Reins Center for Equine Therapy operates, against any and all claims that I may have now or in the future for damages resulting from my failure to wear headgear while riding or participating in equine activities on the premises of Southern Reins Center for Equine Therapy.

I hereby release, waive and discharge Southern Reins Center for Equine Therapy, its officers, directors, employees, volunteers and agents, as well as any affiliated entities or persons, including but not limited to the owners, operators, employees and agents of the facility where Southern Reins Center for Equine Therapy operates, from any and all liability or claims for damages arising directly or indirectly out of my participation in such activities and/or my presence on the Southern Reins premises (including cost and attorney fees), including but not limited to death, bodily injury, or damage to property, regardless of whether or not liability is premised on negligent actions or omissions of such released parties or otherwise.

I hereby agree to indemnify and hold harmless Southern Reins Center for Equine Therapy, its officers, employees, volunteers and agents, together with the owners, operators, employees and agents of the facility where Southern Reins Center for Equine Therapy operates, from any and all suits, demands, actions, losses, liabilities, costs and/or expenses, including attorney's fees, and claims of any type occasioned by, attributable to or otherwise arising out of my involvement in such activities and/or my presence at such facility, for which activities and presence I have duly assumed the risk and for which I am responsible, and for any actions brought by my guests or invitees which may be present on the premises.

CENTER FOR EQUINE THERAPY

LESSON POLICY AND PROCEDURES

- 1. Every attempt will be made to provide a spot in one of our programs to new participants, depending upon the schedule availability, type of disability and/or capability of the therapeutic riding instructor in that particular field of teaching. Occupational Therapy incorporating Hippotherapy scheduling is dependent on the availability of the therapist/s.
- For mounted activities, new participant orientation/assessment will be scheduled prior to every session to introduce new participants to the facility, instructors and horses; however, should there be a scheduling conflict the participant will be introduced to the program on the first lesson. Hippotherapy clients must have an evaluation by a therapist before beginning treatment.
- 3. Participants are encouraged to be ready for their lessons or therapy visits and arrive on time. Participants who are ten or more minutes late may not be permitted to take part in the lesson. Participants who accumulate three (3) unexcused absences in a lesson session will be removed from the program and fees are non-refundable. It is Southern Reins' policy that make-up lessons may only be scheduled due to weather conditions, facility disruptions, or other unforeseen events. Makeup lessons will not be provided for 'no shows.' Only one makeup lesson will be provided for excused absences, regardless of the number of excused absences that are accumulated during the riding session. For all of our programs, anyone arriving past their scheduled start time will only be able to participate for the time that is remaining. Horses are removed from the arena 10 minutes from the scheduled start time. If you arrive more than 10 minutes late and have not contacted us in advance, unmounted services may be provided instead of mounted activities/therapy.
- 4. Late Cancellation Policy: Participants who are unable to attend their scheduled lesson or therapy visit must notify the Head Instructor at least 4 hours prior to the start of the lesson for an excused absence. Lesson fees and therapy visits are non-refundable for missed lessons and visits due to late cancellation (less than 4 hours notice) and Southern Reins will not provide credits, refunds or makeup lessons for late cancellations. Emergency situations are considered excused.
- 5. Lesson fees are due IN FULL for the session at least one (1) week prior to the start of the lesson and participants are required to pay for the entire session fee in advance. Lesson fees are NON-REFUNDABLE and once paid, no makeup lessons are guaranteed. On a case by case basis, lesson fees may be split with half of the payment made before the first lesson, and the second half mid-session for sessions longer than 6 weeks with approval by the Head Instructor. Lesson fee rates will be provided to existing and new participants/parents prior to each session. Participants who foresee missing a lesson(s) prior to payment of the session are advised to contact the Head Instructor prior to the start of the session to make the necessary arrangements. Hippotherapy visits are to be paid in advance in 4 week sessions in most cases. Occasionally during certain times of the year these visits are offered in shorter sessions.
- 6. Children under the age of 16 who are not enrolled in the program must be accompanied by an adult at all times. No pets are allowed on the property.
- 7. Southern Reins Center for Equine Therapy has a weight limit of 180 lbs. This limitation has been established to ensure the soundness and well-being of all program horses. Special considerations will be reviewed on a case-by-case basis and applicants/participants are encouraged to discuss these considerations with their Instructor, including current roster participants who may exceed that weight limit over time.
- 8. Appropriate riding attire is highly recommended. Breeches or pants are appropriate, as well as boots or shoes with a heel (no sandals, pumps, or slides). Skirts and shorts are discouraged to ensure the comfort of the participant.

SOUTHERN REINS CENTER FOR EQUINE THERAPY PARTICIPANT COVID-19 HEALTH AND SAFETY REQUIREMENTS, RISK ACKNOWLEDGMENT, AND RELEASE OF LIABILITY AGREEMENT – PAGE 1 OF 2

Name of Participant:

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Southern Reins Center for Equine Therapy is taking active measures to reduce the spread of COVID-19 at our facility; yet there are still risks associated with participating in the programs offered that may increase exposure due to required personal contact and person-to-person interaction. Any individual, including you, your participant, or attending family member who visits the farm for a lesson or session should follow personal hygiene safety standards; including but not limited to wearing a mask, gloves, thoroughly washing hands and applying hand sanitizer, and practicing social distancing. Family members and caregivers are limited to a maximum of two (2) for any lesson or session. Southern Reins Center for Equine Therapy remains closed to guests and other individuals who are not related to a participant. Attending family members are encouraged to remain in their vehicle during the scheduled lesson or session, and will only be permitted in designated areas of the facility.

If you, your participant, or attending family member has been exposed, or may have been exposed, to an individual with COVID-19; or an individual who is symptomatic of COVID-19, you or your participant may not take part in lessons or sessions and may not visit the facility. By signing this agreement, you agree that if you, your participant, or an attending family member has not had an illness at least two (2) weeks prior to the start of the lesson or session. An illness includes, but is not limited to, sneezing, coughing, fever, nausea, and congestion. If you or your participant has had an illness within 2 weeks, you may not take part in lessons or sessions, or visit the facility. Recovered illnesses require a physician's documentation that you or your participant is healthy and may return for lessons or sessions.

Southern Reins has implemented safety measures to reduce the risk of exposure to COVID-19. Attached to this agreement is our COVID-19 Action Plan and Preparedness document, as well as our COVID-19 Safety Protocol for Operations that details safety measures and precautions to serve participants at the facility. Southern Reins cannot guarantee that you, your participant, or attending family member, will not become infected with COVID-19. Further, by signing this agreement, you acknowledge that participating in activities offered at the Southern Reins Center for Equine Therapy could increase the risk that you, your participant, or attending family member may contract COVID-19.

By signing this agreement, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you, your participant, or attending family member may be exposed to or infected by COVID-19; and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

By signing this agreement, you voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to yourself, your participant, or attending family member (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, in connection with lessons and sessions offered at the facility.

By signing this agreement, on behalf of yourself, your participant and your attending family member, you hereby release, covenant not to sue, discharge, and hold harmless Southern Reins Center for Equine Therapy, its employees, agents, and representatives, of and from any and all Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Southern Reins Center for Equine Therapy, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any program offered at the farm.
